Most of the target schools in places like Costa Rica do not have many education reference books or computers. Give-A-Book works to provide books to elementary schools while partnering with other organizations in these regions. Give-A-Book has distributed thousands and thousands of books to schools and community libraries in Pensacola Florida as well as in Central and South America.
